

We have three rules clinics, and six mechanics clinics. To certify for championship play, umpires must attend one rules clinic, one mechanics clinic and pass the ASA online test. We encourage all umpires to attend a rules clinic and mechanics clinic, even if you are not certifying for championship play. The clinics will help you become a better umpire. Clinic dates and information are listed here, and may also be found on the Southern California website.

The rules clinic fee is \$15.00 and the mechanics clinic fee is 10.00. Payment of registration fee, rules clinic fee and mechanics clinic fee may be made using one registration form with one check, or you may choose to pay for the clinics when you attend.

Umpires who attended the ASA National Umpire School in October are excused from attending a Southern California mechanics clinic in 2012. However they must attend a Regional or Southern California Rules Clinic and pass the ASA rules exam. Umpires attending the ASA Fast-Pitch or Slow-Pitch Camp are excused from attending local clinics during the year of attendance. Contact your District UIC if you wish to attend a national school or camp.
